#### **What personal data we collect and why we collect it**

#### **Email**

#### **Media**

If you upload images to the website, you should avoid uploading images with embedded location data (EXIF GPS) included. Visitors to the website can download and extract any location data from images on the website.

NUDUS B.V. processes your personal data because you use our services and / or because you have provided us with these data yourself.

#### **NUDUS B.V. processes your personal data for the following purposes:**

Business Relationships: Personal data from our business relationships is processed to provide our products and services in a well and effective manner. The personal data are collected and processed for the following purposes:

- send invoices and manage payments;
- to inform you about our services and our other activities (for example, by email and invitations to events).

#### **Job applications:**

In order to decide whether or not to accept an applicant or to answer an application letter, we process the following personal data:

- Date of birth (if supplied)

If the applicant gives permission, his data can be kept for a longer period in case another job becomes vacant. For this we use a period of 6 months after the registration process has ended.

#### **Automated decision-making:**

NUDUS B.V. does not make decisions based on automated processing on matters that can have (significant) consequences for people. These are decisions taken by computer programs or systems, without the presence of a person (for example, an employee of NUDUS B.V.).

#### **How long we keep personal data:**

NUDUS B.V. does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected.

#### **Sharing personal data with third parties:**

NUDUS B.V. does not sell your data to third parties and will only provide it to third parties if this is necessary for the execution of our agreement with you or to comply with a legal obligation. We enter into a processing agreement with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. NUDUS B.V. remains responsible for these processes.

**Cookies, Google Analytics or similar techniques we use:**

The website of NUDUS B.V. only uses technical and functional cookies. These cookies are used by the Google Analytics service to keep statistics of our website. This is done by the Google company. Read more about Google's privacy policy [here](#).

The statistics show the visiting and clicking behavior on the website. This way we optimize the information that can be seen on the site. These data are not provided to third parties by NUDUS B.V..
